Editorial

These days the Tahr Cull is the topic on a lot of hunter's lips. While it may not concern some hunters it should concern all who enjoy hunting, fishing and the use of firearms. As we know this cull is being pushed by Eugenie Sage the Minister of Conservation. She is an ideologist of what is commonly called the green persuasion. From the Info I am getting the group she fronts not only wants to get rid of Tahr, but as much introduced Game animals as at all possible, the trout (they are introduced.) Plus preserve the Whitebait for the use of indigenous Kiwis.

This Green movement is a united body, who have an ideological vision of New Zealand. If there was no hunting, and therefore no firearms being owned by hunters, how many firearms owners would be left? A smaller group is easier to push around by those who want no firearms in private hands at all.

The message is now more than ever all who enjoy the outdoors for Hunting, Fishing, and the use of Firearms, must stand united. Each battle is our battle for each and every one of us. Remember all those who do not stand up and be counted as apposing this green vision, are taken as being supporters of this green vision by the ideologists who push this agenda. Tahr 2019 ballot

Hunters need to be aware that:

- applications will only be accepted through the online application form
- applications **open 9 am 1 October and close 4 pm 29 October 2018**
- there are party-size limits for safety and to minimise impacts on campsites:
minimum size 2; maximum size 6

- a one-off non-refundable fee of \$60 will be charged for each application regardless of whether the applicant is successful or not
- all correspondence for the 2018 Tahr Ballot must be sent to haasthuntingballot@doc.govt.nz

Greenstone/Caples

All blocks in the Greenstone/Caples Recreational Hunting Area (RHA) are [restricted permit](#) blocks issued by way of two ballot draws, one for April/May each year (the roar) and one for June to September. Ballot applications are accepted in November and February for the respective ballot periods.
